
**TERMS & CONDITIONS**

(For Empanelment of Guest Faculty in RCA, MPUAT, Udaipur)

**Terms and Conditions:**

The empanelment of guest faculty members shall be executed on the following terms & conditions:

1. The empaneled guest faculty members shall not have any right to claim any kind of regular appointment in the University based on this empanelment.
2. The guest faculty members, if applied for teaching positions, will be treated as fresh candidates at the time of regular recruitment. The guest faculty members hereby undertake not to make any such claim of permanency or regularization, or extension of his/her empanelment and/or a claim to treat him/her for being a regular employee consequent upon this empanelment.
3. The guest faculty members shall be engaged on a purely temporary basis subject to his/her satisfactory performance in whole period of academic session and administrative assignments given during the empaneled period. In case of performance of any empaneled guest faculty is found unsatisfactory, the empanelment shall be discontinued immediately without giving any prior notice.
4. The Guest faculty members shall not be entitled to any kind of leave except University/Gazetted holidays.
5. If any information/document furnished is found to be false/incorrect, the empanelment will be discontinued with immediate effect without giving any prior notice.
6. The guest faculty member has to report his/her duties on or before the date as decided by the College failing which his/her empanelment shall be cancelled automatically.
7. Any empaneled guest faculty teacher found to be involved in malpractices or guilty of misconduct or misdemeanor shall be debarred and punished as per the rules.
8. The Guest Faculty will not be given the benefit of allowances, pension, gratuity and leave, etc., as admissible to the regularly appointed teachers.
9. The payments of taxes including the income tax will be the sole responsibility of the guest faculty him/her only. However, tax deduction at source (TDS) will be affected against the payable remuneration at applicable rates as per the prevailing laws, rules and regulations.
10. In case any guest faculty remains on leave, the same should be reported to the concerned Head of the Department via a formal application/email.
